Mode and Modalities of Examination for UG 2nd, 4th & 6th Semester and PG 2nd Semester.

I. Evaluation of UG Courses (2nd, 4th, & 6th Semester) and 2nd Semester PG Courses shall comprise of following components:

II. Modalities of Comprehensive Viva Voce Examination (CVVE) for (UG-2nd, 4th & 6th & PG-2nd Semsters).

- a) Will be conducted by concerned Faculty through online mode only (Google Meet, Skype, Whatsapp or any convenient mode).
- b) Viva Voce Examination will be based on the syllabi covered through online teaching.
- c) Subject in which numerical analysis or problem solving is imperative, Faculty Incharge is authorized to assess the student through any convenient mode, with an objective to evaluate the comprehension of subject content, which has been dealt through online teaching module.
- d) The CVVE will start from 10th July 2020. Roster/ Schedule for the same shall be made available to the candidates by concerned Heads of the Departments. All HODs are requested to kindly upload the information on Institute Website as well as on their Departmental portals.
- e) Uploading of awards on ERP shall be worked out after obtained marks out of 100 as per components/methodology mentioned in Table I. Afterwards 30%, 10%, 60% corresponding to Mid-Term, Class assessment and End-Term respectively as per ERP existing module will be awarded accordingly.

f) The following time schedule has been approved by Competent Authority for conduct of examination and declaration of results in respect of Spring Session 2020.
