

## Rules of Branch Change

Student admitted to a particular branch of the B.Tech. course will normally continue studying in that branch till completion. However, under special circumstances as an incentive for excellent academic performance in the first two semesters, the institute may permit a student, admitted through JEE to transfer to branch of his choice (provided vacancy has been created) after the first year only. Such changes will be permitted strictly in accordance with the proposed guidelines for the same.

### Guidelines:

1. Students having CGPA  $\geq 8.50$  (Gen. OBC, EWS category) and CGPA  $\geq 8.00$  (SC, ST & PH category) at the end of 2<sup>nd</sup> semester and must have cleared all subjects in single attempt.
2. Candidates should have no F and /or I Grade and should not be involved in any act of indiscipline.
3. The strength of discipline to which transfer is made should not increase beyond the sanctioned strength and the strength from which transference is being made does not fall below 95% of the existing strength.
4. Students interested should apply in prescribed form which will be made available on institute website.
5. Students are advised to consult their parents for change of branch and branch once allotted will be final and binding to the students. They will have to submit an affidavit for the same.
6. Student may also exercise option of branch where vacancies are indicated as NIL, as vacancies subsequently created in re-allotment will be operated as per student option.
7. The allotment will be made on the SPOT purely on merit as per CGPA of the student and the option given by him/her.
8. Merit list will be prepared according to their CGPA in first year. In case of tied CGPA score their JEE Rank (through which they have taken the admission in first year) will be used.
9. The reservations of SC, ST, OBC, PH etc. will be kept as it is and no change of category will be permitted so that overall seat matrix is maintained as per MHRD guidelines.
10. The home state quota and other state quota will be kept as it is as per MHRD guidelines.
11. The students admitted through DASA or GOI nomination will not be permitted to take part in this process.
